#### TERMS AND CONDITIONS

1. SMS service is provided by IGLOW (hereinafter referred to as "IGLOW") subject to the SMS Service Subscriber (hereinafter referred to as "SB") acceptance and continued observance of the terms and conditions herein set out which may be varied at any time by IGLOW, upon 30 days written notice to SB. Upon 30 days written notice to SB if he/she objects to the variation may serve upon IGLOW, not less than 7 days prior to the date upon which variation to these terms and conditions is to become effective, an election to terminate SMS service from such date.
2. The SB warrants that details set out in all sections of the application form, are true in every particular and under takes to immediately notify IGLOW of any changes the SB accordingly.
3. In the event of the application for being signed on behalf of the SB by any person ("the signatory"), the signatory warrants that he/she has the authority to make application for SMS service on behalf of the SB and to bind the SB accordingly.
4. IGLOW shall use its best endeavors to ensure the continuity and efficiency of SMS service at all time but should not be held liable for any loss or damage, consequential or otherwise, arising out of any failure of SMS service however caused, including any default, error, omission or loss, whether negligent or otherwise, in the transmission, reception or use of use of SMS facilities.
5. The SB hereby indemnifies and shall keep indemnified IGLOW from any loss, damage, liability or expenses arising from any libel, invasion of privacy, infringement or copyright, patent, breach of confidence or privilege or breach of any law or regulation whatsoever arising from the material transmitted, received or stored via SMS service and from all other claims arising out any act or omission of the SB or any unauthorised use or exploitation of SMS service.
6. IGLOW reserves the right to vary charges for SMS service. The current charges are published separately by IGLOW and are liable to be changed without notice. Unless otherwise provided by this agreement, all charges shall be payable on demand. The SB will be billed monthly on dates determined by IGLOW. Charges Payable to the subscription and usage of SMS service shall be calculated, except where IGLOW otherwise determines, by reference to the details of usage recorded by IGLOW and not by any apparatus or means used by the SB.
7. The SB shall pay on demand all applicable charges for the SMS service and facilities requested by the SB or person duly authorised by the SB.
8. The SB shall take all reasonable precautions to protect against any unauthorised use of his/ her SMS account and shall at all times responsible for all acts of unauthorised use of this SMS account including the payment of all charges resulting from such use.
9. The SB shall deposit with IGLOW any amount of monies as required by IGLOW from time to time as deposit towards the fees, change and damages payable to IGLOW under this Terms and Conditions and the SBs are not allowed to withdraw the said deposit during the continuance of these Terms and Conditions, IGLOW reserve the right at any time to apply the said deposit for the purpose of setting any fees, expenses or damage due by the SB to IGLOW.
10. All fees, charges, expenses and damages payable by the SB to IGLOW under these Terms and Conditions shall be paid within seven (7) days from the date the Statement of Account is given to the SB.
11. IGLOW reserve absolute right to add, delete or amend any of these Terms and Conditions at any time without notifying the SB of the said additions, deletions or amendments.
12. These Terms and Conditions shall be enforceable on the date determined by IGLOW.
13. Any failure, delay or indulgence of IGLOW to enforce any terms, conditions or provisions of these Terms and Conditions shall not be construed as waiver of any IGLOW right or as affecting the legality or validity of all or any part of these Terms and Conditions or right of IGLOW to take action later.
14. Save and except with the consent in writing by IGLOW, the SBs shall not assign, let or otherwise part with the SMS services or any interest or benefit thereunder.
15. The terms and conditions contained in these Terms and Conditions are subject to the provision of the The Communications And Multimedia Act 1998 and the rules and regulations made in accordance with the said Act and the changes made thereto and other relevant rules and regulations made by the relevant authorities from time to time pertaining to the Telecommunications Services.
16. SB may allow other persons to use his SMS account to get access to the SMS service provided that the SB shall not receive, either directly or indirectly, any consideration or benefits of any kind in return for such use, and ensures that any such person observes the provisions of this agreement and any other conditions as to such use notified by IGLOW to the SB from time to time.
17. IGLOW reserves the right to deduct SB's deposit for any cost incurred by IGLOW to recover any amount due from the SB for the provision of the SMS service and the right to increase SB's deposit from time as it deems fit.
18. The SB shall not use SMS in any manner which in the opinion of IGLOW may adversely affect the SMS by other SBs or the efficiency or security of SMS service as a whole.
19. IGLOW may without prejudice to any other right, claim or action it may have against the SB, immediately after 14 days written notice, discontinue SMS service, if the SB is in breach of any of these terms and conditions contained hereof or any telecommunication service provided by IGLOW to the SB is terminated or cancelled by IGLOW for any reason pursuant to The Communications And Multimedia Act 1998 or under any other agreement in force. In the event of a discontinuance of SMS service, the SB shall have no right or claim whatsoever nature against IGLOW.
20. IGLOW shall not be liable for any breach of this agreement by Act of God, insurrection of civil disorder, war, or military operations, national or local emergency, acts or omissions of Government, highway authorities, or other competent authority, industrial disputes of any kind (whether or not involving IGLOW employee) fire, lightning, explosion, flood, subsidence, inclement weather, acts of omission of persons or persons or bodies for whom IGLOW is not responsible or any other cause whether similar or dissimilar or outside IGLOW control.
21. This agreement shall be deemed to be made in Malaysia and subject to the jurisdiction of the Malaysian Courts.
22. In any proceedings between IGLOW and the SB, certificate of IGLOW that a specified sum is due to IGLOW from the SB for SMS service provided under this agreement shall be conclusive evidence of the fact.
23. This agreement shall be for an initial term of one (1) year and shall there after remain in force until determined by either party giving to the other fourteen (14) days notice in writing or otherwise as provided in the terms and conditions herein.
